

Declaration 4 of 2013

Section 248 of the Anti-Money Laundering and Counter-Terrorism Financing Act 2006

- 1. I, John Lance Schmidt, Chief Executive Officer of the Australian Transaction Reports and Analysis Centre, acting under paragraph 248(1)(b) of the *Anti-Money Laundering and Counter-Terrorism Financing Act 2006* (AML/CTF Act), declare that the definition of 'designated business group' in section 5 of that Act applies in relation to persons specified in paragraph 2 below as if:
 - (a) paragraph (b) of the definition was modified by:
 - (i) omitting 'the AML/CTF Rules'; and
 - (ii) substituting 'Form A attached to this Declaration and provided by the Nominated Contact Officer to AUSTRAC'; and
 - (b) paragraph (d) of the definition was modified by:
 - (i) omitting 'such conditions (if any) as are specified in the AML/CTF Rules'; and
 - (ii) substituting 'the conditions in subparagraphs 2.1.2(2) and 2.1.2(3), and paragraph 2.1.3 of the Anti-Money Laundering and Counter-Terrorism Financing Rules Instrument 2007 (No. 1); and
 - (c) paragraph (e) of the definition was modified by omitting the paragraph and substituting:
 - (e) each member of the designated business group is a reporting entity that is one of the following:
 - Archer Capital Pty Ltd ABN 14 076 176 737 (Archer Capital);
 or
 - ii. an entity that is related, within the meaning of section 50 of the *Corporations Act 2001*, to Archer Capital; or
 - iii. an entity that:
 - is a wholly owned subsidiary of Archer Capital Group Pty Ltd ACN 154 416 510 (as trustee of the Archer Capital Group Custodian Trust); and
 - b. has appointed Archer Capital as manager and investment advisor in accordance with a written agreement between the entity and Archer Capital.

If any of the information submitted by the applicant or its representatives is found to be false or misleading, this declaration may be revoked and action may be initiated against the applicant.
- 3. The person granted this declaration may request the AUSTRAC CEO at any time to revoke or vary the declaration.
