The statistics are provided separately for the 2018/19, 2019/20, 2020,21 and 2021/22 financial years. The final year is incomplete and is provided as of March 25 2022.

SMRs submitted by Casinos

This response presents statistics of SMRs submitted by casinos (Crown Melbourne, Crown Perth, Star Sydney, Casino Canberra, Adelaide Casino, Star Gold Coast, Reef Hotel Casino, Ville Resort-Casino, Treasury Casino, Mindil Beach Casino, Lasseters, Country Club Casino and Wrest Point Hotel Casino) per year 2018-2021.

Statistics are provided per financial year. We provide our best matches to the specified casinos, noting that the registered name and trading name may vary from the casino name specified. In particular, The Star Entertainment QLD Limited is the corresponding reporting entity for both The Star Good Coast as well as the Treasury Casino in Brisbane.
