This is an application for:

- (a) declaratory relief under s 21 of the *Federal Court of Australia Act 1976* (Cth) (**FCA Act**);
- (b) orders for a pecuniary penalty under s 175(1) of the *Anti-Money Laundering and Counter-Terrorism Financing Act 2006* (the **Act**);
- (c) costs under s 43 of the FCA Act;
- (d) such further or other orders as the Court deems fit,

in respect of the Respondent's (**Princeton**) failure to give the Chief Executive Officer of the Australian Transaction Reports and Analysis Centre an AML/CTF Compliance Report in contravention of s 47(2) of the Act.

On the grounds stated in the Concise Statement, the Applicant claims:

Declaratory Relief

1. A declaration that, by failing to give the Chief Executive Officer of the Australian Transaction Reports and Analysis Centre a report relating to Princeton's compliance with the Act, the regulations and the *Anti-Money Laundering and Counter-Terrorism Financing Rules Instrument 2007 (No. 1)* within the lodgment period (1 January 2024 to 1 April 2024) for the reporting period (1 January 2023 to 31 December 2023), Princeton contravened subsection 47(2) of the Act.

Pecuniary Penalty

2. An order pursuant to subsection 175(1) of the Act that within 30 days of the date of this order, Princeton pay to the Commonwealth of Australia a pecuniary penalty.

Other Orders

3. An order that Princeton pay the Applicant's costs of and incidental to these proceedings.
4. Such further or other orders as the Court deems fit.
